- 2. Final list of Candidates is available in the Councils website (Admission will be made based on the RANK of 1st SPOT COUNSELLING mentioned herein from amongst the listed candidates.
- 3. Merit listing of the candidates does not ensure / guarantee admission in the concerned institute and branch. It will depend on the availability of vacant seats and turn-out of the listed candidates, at the applied Institute on 19.10.2022 by 1:00 pm
- 4. Institute gate will be closed at 1:00 pm. No candidate will be allowed to participate at the 1st SPOT COUNSE LING after the reporting time. So interested candidates are requested to ensure that they reach the designated institute well in time.
- 5. Institute will call out the students as per Merit list based on number of vacancies. Once the Vacancies are filled as per candidates present and eligible with their rank in the merit list, no further student's name will be called out.

- 7. Physically Challenged (PC) Certificate in original (required if the category is PC quota only) issued by competent authority.
- 8. Category certificate of the candidate to be verified.
 - Certificate in original with respect to Land Loser issued by competent authority of Government of West Bengal (required if allotted through LLQ quota only).
 - Certificate in original with respect to tuition Fee Waiver (TFW) Scheme issued by competent authority (required if allotted through TFW quota only).
 - Certificate in original with respect to Wards of Ex-serviceman issued by competent authority (required if allotted through EX Serviceman quota only).
 - Certificate 1n original with respect to Economically Weaker Sections issued by competent authority (required if allotted through EWS quota only).
